२. महाविद्यालयाची संलग्नता, आवश्यक शैक्षणिक सोयी/सुविधा उपलब्ध करून देणेचे अधीन राहिल.
३. मान्यता पुढे चालु ठेवणे, स्थगित अथवा रद्द करण्याचे हक्क विद्यापीठाने राखून ठेवले आहेत.

४. आपण नियुक्त केलेल्या कर्मचा-यांच्या सेवा विषयक बाबींची व त्यांच्या वेतनाची संपुर्ण जबाबदारी आपल्या संस्थेची राहिल. या बाबत विद्यापीठ कुठलीही जबाबदारी घेणार नाही.
५. आपल्या महाविद्यालयाची प्रवेश क्षमता ४० राहिल.

Sub : Grant of recognition to start new College of Agril. Bio-Technology,
on non-grant basis..... Academic year 2009-10.

Sir,

It is my pleasure to inform you that, the Executive Council of this University in its meeting held on 10/7/2008 has accepted the recommendations of the Academic Council on the basis of the reports submitted by Chairman, Local Enquiry Committee to grant provisional recognition to your institute to start the College of Agril. Bio-Technology at Paud Dist. Pune from the Academic year 2009-10.

As per the revised regulations issued by the Government of Maharashtra and norms of ICAR/University before granting final recognition, it is mandatory that, the institute should have 20 ha Agricultural land in the name of the institute as per the land records of the revenue department. Further, all the infrastructure facilities required are to be completed and made available by the institution before the permission is granted to admit the students. The copies of GR & detailed list of infrastructure required for the college are appended herewith.

You are therefore, requested to send your acceptance of these conditions and your willingness to start the above mentioned college at your institute from 2009-10. If you are willing to start college, you will have to deposit amount of Rs. 5.00 lakhs by Demand Draft Drawn on SBI, MPKV, Rahuri (Code No.3239) and bank guarantee of Nationalised bank for Rs. 5.00 lakhs in the name of Comptroller, MPKV, Rahuri and submit the land record in support of your claim

that the institute has 20 ha Agricultural land. The University will seek the advice of the University legal advisor and obtain search report of property made available for the proposed college.


The proposed college will be governed by the rules and regulations of the Mahatma Phule Krishi Vidyapeeth, Rahuri in operation and made from time to time. The brief outline of the conditions is also attached herewith. The provisions of rules framed by the acts of the Government / University statute, account code & academic rules and regulations will also be applicable to the college. The Syllabus of the course will be as per the decision of the university and college have to follow it.

It may be noted that the University has intimated this provisional recognition so as to enable you to prepare your self for starting college admission from the ~~year~~ academic year 2009-10 and to have sufficient time for making arrangement for buildings/laboratories and purchase of field implements, lab equipments, instruments, furniture etc.

It is expected to prepare yourself with all infrastructure by the January, 2009 as the latest. After hearing from you, a committee under the Chairmanship of Director of Instruction of the University will visit your institute and after receiving the satisfactory report from the committee the same will be placed before the statutory bodies of the University to grant temporary recognition. Then the proposal will be submitted to MCAER, Pune for granting necessary permission. If you failed to provide required facilities by the end of January 2009, the University has liberty to cancel the provisional affiliation granted for the college.
